## Introduction

## Background

The contemporary landscape of higher education in Nigeria demands that universities evolve from being merely administrative entities to becoming agile, strategic, and innovative institutions. The Governing Council, as the apex policy and governance body, holds the pivotal mandate to steer this transformation. ## Key Objectives

internalize the distinct yet complementary roles of Council vs. Management in driving institutional strategy.

3. Champion Innovation & Digital Transformation: Explore the Council's role in fostering a culture of innovation in teaching, research, administration, and revenue generation, including the adoption of educational technology (EdTech).
4. Leverage Expertise for Effective Governance: Enhance capabilities in financial stewardship, risk management, performance evaluation (of the University and Principal Officers), and ethical leadership.
5. Build a Cohesive & High-Performing Council: Strengthen internal collaboration, communication, and committee effectiveness to present a united, strategic front.

## Expected Outcomes & Deliverables

1. A "Council Governance Action Charter" outlining specific priorities for the next 12-18 months.
2. Enhanced personal competence and collective confidence of Council members.



3. A **refreshed perspective** on the University's Strategic Plan with clear suggestions for refinement.
4. Strengthened **internal networks and communication protocols** within the Council.
5. A comprehensive **workshop report** with recommendations for the University.

### Teaching/Learning Modules

The core teaching/learning components will address the following themes:

- Foundation & Strategic Foresight: The Strategic Council – Setting the Direction for Growth
- Innovation & Stewardship: The Innovative & Accountable Council
- Expertise, Dynamics & Forward Action: The Effective Council – Building Cohesion and Delivering Impact

### Workshop Methodology

The workshop will be highly interactive, participatory, and solution-focused, moving beyond lectures to actionable outcomes. Methods will include:

- **Expert Presentations:** By seasoned academics, governance experts, and industry leaders.
- **Case Studies & Scenario Analysis:** Nigerian and international university cases on governance success and challenges.
- **Breakout Group Work:** Council Committees (e.g., Finance & GPC, Academics & Research, Establishment, etc.) to tackle specific, real-world university issues.
- **Panel Discussions:** Featuring former Council Chairmen, Vice-Chancellors, and NUC representatives.
- **Experience Sharing, Peer Exchange & Networking Sessions:** Structured sharing of experiences among members.

- **Action Planning Sessions:** Development of a Council Governance Work Plan.
